REQUIREMENTS

for the Preparation of Presentation Abstracts

The Conference Organizing Committee accepts presentation abstracts with a maximum length of 5 pages, typed in Microsoft Word, using Times New Roman font, size 14, 1.5 line spacing, with all margins set to 20 mm, and a 1.25 mm paragraph indent. The first line should include the last name, first name, and patronymic; the second line should include academic degree and title (for postgraduates – academic year and major); the third line should include position and the name of the educational institution; the fourth line – *ORCID*, the fifth line - should present the title of the presentation in uppercase letters, bold font, centered, the sixth line - keywords. At the end of the text, include a bibliography (references in the text should be cited as follows: [7, p. 123], where 7 is the source number in the list, and 123 is the page number. Multiple references can be cited as [1; 4; 8] or [2, p. 32; 9, p. 48; 11, p. 257]).
